



CHILDREN AND FAMILIES WERE PROVIDED WITH ACCESS TO HEALTH INTERVENTIONS

In 2020, despite the pandemic, we ensured that the most vulnerable children, adolescents, and parents/ caregivers, including expectant mothers and babies, received care and have access to health information and services, medical care facilities, food and micronutrient supplements, and social protection programs. We worked closely with health and nutrition service providers and local government units (LGUs) in rural and urban program areas, as well as the national government to strengthen policies and systems for children. And we worked with adolescents, their families, and communities to ensure that young people's particular health needs are met.

"I am Merlina, 26 years old and a mother of three children - Timothy, 6, Feliza, 5 and Aldrin Jr., three months old. I am also breastfeeding my youngest son. We have been staying here in this housing site for almost a year already. I live with my husband Aldrin, my three kids and my sister Martina, 30 who has mental disability.

Before I gave birth, I used to sell rags at the public market of Tanay and my husband is a construction worker in Laguna. Because of the quarantine, my husband's work was temporarily stopped.

I am happy that I am able to successfully breastfeed Aldrin Jr., aside from it being very practical, I have been told by health workers here that it is also healthy for my baby.

I am happy that we are able to receive these food packs and family hygiene kits (from Save the Children) because right now, we really don't have money and fear that we will run out of money to buy food.

I am also thankful for the hygiene essentials because with whatever we have, we would always prioritize buying food and will have nothing left to buy for (sanitizing) alcohol or even a mask."



PROGRAM HIGHLIGHTS IN OUR PROJECT AREAS

"I really miss going to school in my uniform, and to read and write. Now, I'll be able to study and use the learning kit Save the Children gave me for my online learning. This is a big help for us."

Teacher Claudine and her Special Education (SpEd) students were greatly affected by the closure of schools in 2020 due to the pandemic. But they are grateful because they will be able to continue their online distance learning through the OPPO A12e smartphones and Rock Space Torch Bluetooth Earphones they received from Philippine Oppo Mobile Technology that gladly responded to Save the Children Philippines' Project ARAL (Access to Resources for Alternative Learning) - our flagship COVID-adapted Education Program that aims to provide children from vulnerable communities access to quality and inclusive resources for continued learning.

"We had a virtual orientation on how modular learning will be done... You really have to do everything and explore all means. This is not a normal problem because of the pandemic.



For Special Education students, they need immediate feedback. They need an individualized approach. However, parents are not trained to that. If the foundation and follow-ups within the home are not that strong, regression will increase."

KASALI Project wins 2020 global award for Innovative Education Programming



Krystel is one of the 78,000 children reached by Save the Children's KASALI (Education for All Children) Project whose story remains an inspiration to all.

She was diagnosed with "Global Developmental Delay" but through the interventions of the KASALI Project, her family learned how to help in her learning, as well as in her physical growth and development.

Krystel has greatly improved since the first day of school. Now, she actively participates in class, and even mutters sounds and syllables. She too, can stand on her own and make small steps.

"Krystel is very happy in class. We had a class picture just recently and she was driving away her mother because she wanted to be in the photo with just her classmates," said her teacher Adoracion.

REACHED TO PROTECT CHILDREN AND YOUTH FROM ABUSE, EXPLOITATION, AND VIOLENCE

Even amidst the pandemic, Save the Children Philippines contributed to increased access to information on child protection risks, and what parents, caregivers, teachers, and other stakeholders can do to help protect children by adapting existing modules on Positive Discipline, Psychological First Aid for Children and Psychosocial Support for Adults for delivery using different platforms.

Carlo, 18, is a child in conflict with the law (CICL) charged with a drug-related case. He is staying in Bahay Pag-asa (temporary shelter). According to Carlo, the COVID-19 pandemic and quarantine restrictions affected their court hearings and delayed the scheduled release of some CICL. His court hearings were on hold for four months since the announcement of lockdown in March, until online court hearings started in May.

"I felt sad when I learned about the 122 children deaths in the anti-illegal drugs campaign because these children were not given a chance to live, be with their loved ones, and were robbed of their future," Carlo shared.

In April 2020, Save the Children Philippines provided hygiene essentials to their rehabilitation center to help mitigate the risk of COVID-19. Children's consultations and learning sessions on children's rights with CICL were also facilitated in November and December.

"It is very important for children and youth like me to learn about our rights, be heard, and consulted. Through education, I can have a better future and be able to help my family once I get a job," Carlo said.

Protecting Children in the Anti-Illegal Drugs Campaign (ProAct) is a project of Save the Children Philippines that aims to build stronger child protection systems, protect children from the adverse impacts of the anti-illegal drugs campaign, and promote nonviolence and respect for human rights at the national and local level.

"There should be a fair treatment to everyone, because we are all human," Carlo added.

CHILD PARTICIPATION AND CHILD RIGHTS GOVERNANCE

53,589 REACHED TO EMPOWER CHILDREN ON THEIR RIGHTS AND TO BE HEARD

Children were not spared from the impacts of the COVID-19 pandemic as well as the quarantine rules and quidelines imposed by the government which exposed them to unprecedented concerns on health, education, and protection. To ensure that they are able to survive and thrive in the new normal, Save the Children Philippines implemented programs which allowed children to participate and call for government and stakeholder action and accountability on pressing children's rights issues. This led to several local government units (LGUs) to adopt policies and/or plans of action incorporating children's concerns.

Save the Children Philippines' technical support and contributions enabled the Civil Society Coalition on the Convention on the Rights of the Child (CRC Coalition) to submit child rights monitoring reports to UN Human Rights bodies highlighting key issues affecting children's right to health, education, protection and participation (e.g. discrimination based on sexual orientation/gender identity and expression [SOGIE], and disability, impact of the anti-illegal drugs campaign on children, corporal punishment, OSAEC, child marriage, protection of children in situations of armed conflict, etc.). As part of Child Rights Governance, we supported the national government and LGUs in strengthening risk reduction mechanisms.

PROGRAM HIGHLIGHTS IN OUR PROJECT AREAS

16 children and youth groups and a national children's coalition submitted reports and policy proposals on health, education, and protection concerns

11,831 barangays accessed the Quality Assurance System portal to improve the quality of their Barangay Disaster Risk Reduction and Management Plan (BDRRMP)





Both Ericka and Jeffrey belong to community-based children's groups that are members of a national coalition of children's organization called C2C (Children Talk to Children about the UN Convention on the Rights of the Child).

They were trained on how to monitor children's situation in their communities, to gather and analyze data on the experiences and views of children on key issues through interviews, mini-surveys, focus-group discussions and consultations, and to package their findings into key messages that they can use to advocate with government stakeholders at national and local levels.

After years of data gathering, Ericka and Jeffrey finally presented the "First Filipino Children's Report" and proudly represented C2C in a closed-door online children's dialogue with the members of the UN Committee on the Rights of the Child on October 5, 2020. They called on the world's governments to pass laws that would address different children's rights issues.

"We hope that through our report, the government will get to know and consider the possible solutions that children are recommending that will help put an end to some of the issues that we are facing as children. It is important that the president and others in the government see the importance of the data, recommendations and issues that we have presented on our report," said Ericka.

"We call on the government to open its mind to our report and study its content because this report went through a long process, and was carefully thought out by us children. It has valid data gathered directly from children, and we children are the only ones who have directly experienced these issues," added Jeffrey.

C2C was established in 2009 by Save the Children and partner civil society organization, the Samahan ng Mamamayan – Zone One Tondo, Inc. (ZOTO), as a venue for various children's organizations to come together to learn about children's rights and how to monitor how these rights are being implemented in their own communities.

Amalia is a mother of four who lives in a rural area in the province of Leyte. When she heard about the opportunity to be a volunteer facilitator for Save the Children, Amalia jumped at the chance. "I wanted to learn, to expand my knowledge about how to facilitate and face a crowd," she said.

In this role, she learned new things about herself. "I realized that I am a mother who had many shortcomings towards my children," she said. "I gave them food, took care of their schooling, provided their allowance, and I thought this was enough."

Through the training sessions on Positive Discipline, Amalia gained a better understanding on the importance of cultivating an open relationship with her children. She learned that showing her children that she loved them by communicating even in simple ways like asking them how their day was, is as important as providing them with their everyday needs. This demonstrates a balance of both warmth and structure and can make the child more comfortable in sharing things like problems with their parents, which can lead to a closer and more understanding relationship between them.

This new way of parenting had such a profound effect on Amalia's eldest, Jonamae, and inspired her to become a volunteer facilitator like her mother. Amalia's advice to other parents: "It's not too late to change and show your children you love them." She said that even if you don't have children, you could still apply these practices in dealing with children in your community. And this can help their development as adults.

FUNDRAISING

Heroes from Home

Many individuals heeded Save the Children Philippines' call to be "heroes from home" for children. The #HeroFromHome campaign launched in July 2020 encouraged individuals to create their own fundraisers, while staying safe in their own homes. The campaign supported children's educational needs during the time of pandemic. Donations collected went to Save the Children Philippines' COVID-19 response which includes the implementation of Project

ARAL (Access to Resources for Alternative Learning).





The Enopia family from Imus, Cavite, started their own mobile cafe called "The Cooking Dad Bake & Brew" as a workaround to survive the pandemic. Since June, they have been donating 10% of their sales to Save the Children to help ensure that children can continue learning. Each family member has a role to play in this initiative with John Eric "The Cooking Dad" in charge of the baking, mommy Sheng taking care of purchasing and accounting, and their kids Shayne, 11, and Uno, 7, managing their monthly donations.

Through the support of our donors, we are able to provide children with the support they need. The Enopia family is a perfect example indeed that despite limitations, as long as you have the heart to create a lasting change for children, you can be a hero from home.


Rafraf, 15, was born with an orthopedic disability. He lives in a small community in the town of San Miguel in Catanduanes. Landslides and flash floods by Typhoon Goni destroyed most of the houses in the area, including the abaca plantation, which is the primary source of livelihood of the community, including their family. He recalls how 13 family relatives, whose houses were made of lightweight materials, stayed in their 10-square meter concrete house during the typhoon to seek shelter. They then stayed in evacuation centers as they were left homeless.

"I am grateful that our family is safe and we still have our house, but I am worried for my parents who no longer have any livelihood after the typhoon swept off the abaca plantation. I miss being able to meet and talk to my friends and classmates, and wonder how they are right now. Unlike other kids who get to play outside, I am stuck at home without any means of reaching out to them. I fear that most of them have been displaced by the typhoon." - Rafraf


FINANCIAL REPORT 2020

The operations of Save the Children Philippines for 2020 were mainly funded by grants from sponsorship, corporate donors, international humanitarian and development organizations either directly to Save the Children Philippines or through various Save the Children Members. Grants were also received from donors within the Philippines.


Of the PhP 815 Million total funds received in 2020, PhP 350 Million (43.1%) came from the United States, PhP 170 Million (20.8%) was locally raised in the Philippines, PhP 94 Million (11.6%) came from Sweden, PhP 85 Million (10.4%) came from Australia, and a total of PhP 115 Million (14,1%), came from various donors of less than 5% each.

Of the total PhP 800 Million spent in 2020, PhP 651 Million (81.3%) was spent for Programming, PhP 59 Million (7.4%) was spent for Programming Support, PhP 53 Million (6.6%) was spent for Support Services and Administration, PhP 30 Million (3.8%) was spent for Fundraising, and PhP 8 Million (1%) was spent for Advocacy and Campaigns.



Program Implementation Costs utilization were primarily towards:

- 1) HIV/ AIDS (PhP 192 Million)
- 2) Education (PhP 160 Million)
- 3) Cross-thematic which covers all themes/ areas of work including Health and Nutrition, Child Protection, Child Rights Governance, as well as Emergencies, Livelihood, and Fundraising (total: PhP 310 Million).
